I, _____, do hereby give my child, _____, permission to participate in all activities of the Grace Covenant Baptist Academy afterschool program and do realize this may include field trips which will be announced at the appropriate time. Field trips may be changed due to weather or other unforeseen circumstances. I understand that all field trips will incur an additional cost above and beyond the enrollment fee and weekly tuition fee. I understand I must sign a permission form before my child will be permitted to go on any field trips.

I have read the *Parent's Statement of Understanding and Agreement Form* and have been made aware of the policies and procedures of Grace Covenant Baptist Academy. I understand the policies, rules, and payment schedule of the program, and do hereby agree that my child and myself will comply accordingly.

If, in the judgment of the Director, Assistant Director, or supervisory staff in charge, a decision is made that the person picking up my child from the Academy is incapacitated in their ability to remove the child from the Academy, then the other parent or an authorized emergency person with permission to pick up my child will be called to make a decision as to who will come to the Academy for my child. Furthermore, I understand that the Director, Assistant Director, or supervisory staff in charge may contact law enforcement or proper authorities if they feel the action is deemed necessary for the protection of the child.

I, _____, the parent or legal guardian, realize that when my child is removed from the Academy at my request, with permission from the Director or Assistant Director, Grace Covenant Baptist Academy is released from any and all liability for the child's safety, health, and welfare upon leaving the building. Liability then becomes the responsibility of the parent and/or guardian or authorized person who removes the child from the supervision of the afterschool staff. In the event I must contact the Academy by telephone to advise the Director or Assistant Director that another person will be picking up my child, I understand that the Director or Assistant Director will take the information and then contact the parent and/or legal guardian at the telephone number listed on the enrollment form to verify that the parent and/or legal guardian has, in fact, given permission.

No child may leave the Academy with another parent/child enrolled in the program without prior written/dated consent from the parent and/or legal guardian.

The parent and/or legal guardian must comply with TCA 36-6-105 (a copy of this statute is available in the Academy office) to provide reasonable notice of change in physical custody with a certified copy of a valid court order to be provided to the Academy office.

I understand that if any unauthorized person calls for my child, he/she will be refused information or permission to leave the Academy with my child until the parent and/or legal guardian or authorized person can be contacted.
